






#### Welcome







The Scottish COVID-19 **Inquiry** is a team of people who are finding out what happened during the COVID-19 pandemic in Scotland.

An **inquiry** is a review into what went well and what could have been done better.

### **Preliminary Hearing**



A **preliminary hearing** is the first important meeting when the Inquiry explains how it will do its work.

The Inquiry's **preliminary hearing** for health and social care was on 28 August in Edinburgh.



It was shown live on the <u>Inquiry's</u> YouTube channel.

You can watch it, and read what was said on the <u>Inquiry website</u>.



There is also a short film on the website that was shown at the hearing.

It recognises the suffering that COVID-19 caused to the people of Scotland.

# How the hearings will happen



An **investigation** is when a person or organisation looks for facts, figures and information to find out exactly what happened.



The Inquiry has 3 themes at the **investigations** and hearings:

- health and social care
- education and young people
- finance, business and welfare



For each theme, the Inquiry will look at:

- the effect of the pandemic
- how things were put in place to keep us safe
- how important decisions were made





The next hearings start on 24 October in Edinburgh.

They will be about the effects of the pandemic on health and social care.



Hearings will stop for the festive period and start again in February until Easter.

There will then be hearings about the effects of the pandemic for the other 2 themes.



The UK Covid-19 Inquiry is looking at how the pandemic was handled across the UK.

It will hold hearings about Scottish matters in January.



The Scottish COVID-19 Inquiry's hearings will stop for a while to let people and organisations from Scotland to be at the UK hearings.





In July the Inquiry had a session about the COVID-19 virus.

The website also has **transcripts** and reports from the session.

**Transcripts** are documents that show what was said at the session.

# **Chief Executive to the Inquiry**



In July, Ian Duddy became Chief Executive to the Inquiry.

This means he is the most senior official to the Inquiry and is responsible for making sure the Inquiry is run well.

We would like to hear more from minority ethnic groups too.







# **Long COVID**



**Long COVID** is the health problems that last or develop after someone has had COVID-19.

The Inquiry's investigation will look at long COVID as part of checking how Scotland responded to the pandemic.



The Inquiry cannot look at research into the future treatment of long COVID.
